It is also in charge of publishing alerts about hazardous foods through the Coordinated System for the Rapid Exchange of Information (SCIRI in Spanish). This food alert network is active 24 hours a day / 7 days a week, coordinating actions at the national, European, as well as international level.

In the area of nutrition, it has developed the NAOS strategy (Nutrition, Physical Activity and Prevention of Obesity) which promotes and coordinates policies and initiatives to encourage the adoption of healthy diets and physical activity, fostering educational and informative activities aimed at consumers. This strategy aims at preventing obesity, especially in childhood reducing also health inequalities facilitating public access to healthier options while contributing to reduce the environmental and climate footprint of the agri-food sector.

AESAN is also involved in knowledge management through an external Scientific Committee and an Obesity Observatory. It is in charge of national and international cooperation with institutions related to the subject.
